***AGE RELAXATION:** The upper age limit will be relaxable for ST candidates by 5 years. For candidates who belong to PwBD category having minimum 40% disability or more will get 10 years relaxation in upper age limit in addition to the relaxation applicable to the categories mentioned above. TERMS OF ENGAGEMENT & REMUNERATION:

Project Engineer-I will be engaged initially for a period of **Three** years which may be extended up to maximum of **ONE** year (**Maximum tenure of 4 years**) based on requirement and individual performance. Candidates will be paid a consolidated remuneration as follows:
